SUBJECT

ACCREDITATION OF SIXTEEN (16) FOREIGN MEAT

ESTABLISHMENTS (FMEs) OF INDIA AS EXPORTER OF FROZEN INDIAN BUFFALO MEAT INTO THE PHILIPPINES UNDER AHTN

CODE 0202.30.00

WHEREAS, Department of Agriculture Administrative Order No. 16 (DA-AO 16) Series of 2006, otherwise known as the Pre-Border Measures for the Export of Meat and Meat Products to the Philippines provides procedures and guidelines in the accreditation of Foreign Meat Establishments (FME) producing meat and meat products for export to the Philippines;

WHEREAS, Department of Agriculture Administrative Circular No. 12 (DA-AC 12) Series of 2015, otherwise known as the Updated Rules and Regulations Governing the Allocation, Importation, and Utilization of Fresh Frozen Buffalo Meat from India, provides general guideline in the conduct of inspection mission;

WHEREAS, Department of Agriculture Administrative Circular No. 1 (DA-AC 1) series 2017 and Department of Agriculture Administrative Circular No. 4 (DA-AC 4) series of 2017, were technical reference used by the DAIM auditors in the conduct of evaluation for the inspection mission;

WHEREAS, through a series of public consultations organized by the Department of Agriculture-Philippine Council for Agriculture and Fisheries with external stakeholders, Department of Agriculture Administrative Circular Number 6 Series of 2018 was approved and published in the Philippine Daily Inquirer newspaper of general circulation last September 1, 2018;

WHEREAS, a total of thirty (30) FMEs were inspected/audited last November 20 to December 4 2017 by the Department of Agriculture Inspection Mission (DAIM) and sixteen (16) were found to be compliant with the Philippine quarantine and meat inspection systems rules and regulations, two (2) failed to meet the required standard while twelve (12) FME accreditation were deferred for further deliberation by the ARB due to major non-conformances;

WHEREAS, the sixteen (16) FMEs have complied with the requirements provided in the Terrestrial Animal Health Code of the World Organization for Animal Health (Office International des Epizooties-OIE);

WHEREAS, after thorough evaluation of the animal health status and food safety measures, the application of the sixteen (16) FMEs of India for accreditation to export Indian Buffalo Meat (IBM) into the Philippines have been found to be satisfactory and acceptable;

WHEREAS, the Accreditation Review Body (ARB) through a resolution recommended the accreditation of the sixteen (16) Foreign Meat Establishments in India of which eleven (11) are new accreditation and five (5) were renewal/revalidation of accreditation;

NOW, THEREFORE, I EMMANUEL F. PIÑOL, Secretary of Agriculture, by the powers vested in me by law, do hereby issue this Order of accreditation to the following sixteen (16) Foreign Meat Establishment (FMEs) in India to export Frozen Indian Buffalo Meat (IBM) into the Philippines for three (3) years effective October 1, 2018 until September 30, 2021, provided that an annual surveillance audit shall be undertaken by the Department of Agriculture Inspection Mission (DAIM):
