**SUBJECT: CREATION OF THE NATIONAL COMMITTEE FOR FAMILY FARMING FOR THE UNITED NATIONS DECADE OF FAMILY FARMING 2019-2028, AND DESIGNATION OF THE AGRICULTURE TRAINING INSTITUTE AS LEAD AGENCY**

---

The United Nations General Assembly, in its 72<sup>nd</sup> Session, proclaimed the UN Decade of Family Farming (UNDFFF) 2019-2028 to serve as a framework for countries to develop public policies and investments to support and strengthen family farming, and contribute to the achievement of the UN 2030 Agenda for Sustainable Development. The Global Launch of the UNDFFF was held on 29 May 2019 in Rome, Italy.

In this regard, a National Committee for Family Farming (NCFE) is hereby created to support the Department of Agriculture, as UNDFFF National Focal Point, in the implementation of the Decade in the country and to undertake activities relating to this program. In particular, the committee will:

1. Raise awareness on the primordial role of farming systems based on the family unit in sustainable food production and in promoting food security and nutrition;
2. Serve as a platform to facilitate inclusive dialogue on family farming at the national level;
3. Strengthen and advocate for targeted public policies for family farming at national and subnational levels;
4. Formulate and execute a national action plan for the implementation of the Decade, including its monitoring and reporting mechanisms;
5. Contribute to the regional and global discussions through participation in relevant fora and meetings, and the Family Farming Knowledge Platform (FFKP) network;

The committee shall be composed of the following:



The committee will discuss and establish its operational procedures, including subcommittees and/or sub-focal points, such as on policy and legislation, communications, and resource mobilization, and the setting up of the secretariat.

All officials and employees of the various Departments including Bureaus, Attached Agencies and Corporations, DA Service Units and Regional Field Offices are hereby advised of this designation and directed to give full support and cooperation to the National Committee for Family Farming in the performance of its functions.

Expenses to be incurred by the members of the NCFE in the performance of their functions shall be charged to their respective offices, subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and remain in force until otherwise amended or revoked in writing.
