ADMINISTRATIVE CIRCULAR

SUBJECT: APPROVAL OF BÁBOLNA- TETRA KFT IN HUNGARY TO EXPORT DAY OLD CHICKS AND HATCHING EGGS TO THE PHILIPPINES

WHEREAS, pursuant to the Department of Agriculture-Administrative Order No. 9, series of 2010 entitled: Department of Agriculture Administrative Order No. 8, series of 2009, as amended (DA-AO No. 8, series of 2009 entitled: Rules and Regulation Governing the Importation of Agricultural and Fishery/Aquatic Products, Fertilizers, Pesticides and other Agricultural Chemical, Veterinary Drugs and Biological Products into the Philippines), the exporting company is registered/accredited by the concerned DA bureau or agency and is in "good standing";

WHEREAS, the Bureau of Animal Industry conducted an ocular inspection in representative farms in Hungary to evaluate the biosecurity, animal health program, animal disease diagnostic capacity as well as the husbandry practices implemented, in line with the initiative of Bábolna- Tetra Kft to export Day-Old Chicks (DOCs) and Hatching eggs to the Philippines;

WHEREAS, Bábolna-Tetra Kft have complied with the standards provided in the Terrestrial Animal Health Code, 2019 of the World Organisation for Animal Health (OIE);


WHEREAS, based on the inspection/evaluation conducted to Bábolna-Tetra Kft, the Bureau of Animal Industry found no imminent risk to source DOCs and hatching eggs from Bábolna- Tetra Kft in Hungary for export to the Philippines;

NOW, THEREFORE, I, WILLIAM D. DAR, Secretary, Department of Agriculture, by the powers vested in me by law, do hereby issue this Circular granting approval to farm of Bábolna- Tetra Kft in Hungary to export DOCs and hatching eggs into the Philippines:
