SUBJECT: AMENDMENT TO SPECIAL ORDER NO. 65, SERIES OF 2019 "AUTHORITY TO CONDUCT AND ATTEND THE FY 2019 1st, 2nd, 3rd and 4th QUARTER ASSESSMENTS OF THE HIGH VALUE CROPS DEVELOPMENT PROGRAM"

In view of the need for additional time to prepare for the presentation of the accomplishments of the High Value Crops Development Program (HVCDP) for the 4th Quarter of FY 2019, Special Order No. 65, Series of 2019, dated January 16, 2019, is hereby amended as follows:

2.
