MEMORANDUM ORDER

No. 05

SUBJECT: TEMPORARY BAN ON THE IMPORTATION OF DOMESTIC AND WILD BIRDS AND THEIR PRODUCTS INCLUDING POULTRY MEAT, DAY OLD CHICKS, EGGS AND SEMEN ORIGINATING FROM POLAND

WHEREAS, Section 1770 of Act No. 2711 (Revised Administrative Code of 1917) which was adopted by incorporation together with Sections 1761-1769, in Section 5 of Act 3639 (Charter of Bureau of Animal Industry) empowers the Department Head to issue a general order preventing the entry of animals, animal effects, parts or products from any country with dangerous communicable animal disease;

WHEREAS, based on the official report submitted by Dr. Bogdan Konopka, Chief Veterinary Officer, General Veterinary Inspectorate, Ministry of Agriculture and Development, Warsaw, Poland to the World Organisation for Animal Health on 2 January 2020, there was one (1) outbreak of H5N8 Highly Pathogenic Avian Influenza (HPAI) in Uscimow, Lubartowski, Lubelskie Region affecting turkeys on December 30, 2019, as confirmed by the National Veterinary Research Institute in Pulawy, Poland;


WHEREAS, there is a need to prevent the entry of HPAI virus to protect the health of the local poultry population;

NOW, THEREFORE, I, WILLIAM D. DAR, Secretary, Department of Agriculture, by the powers vested in me by law, do hereby institute the following measures for the importation of domestic and wild birds and their products from Poland:

1. Banning the importation of domestic and wild birds and their products, including poultry meat, day old chicks, eggs and semen;
2. Immediate suspension of the processing, evaluation of the application and issuance of Sanitary and Phytosanitary (SPS) import clearance to the above-stated commodities;
3. Stoppage and confiscation of all shipments of the above stated commodities (with the exception on heat treated products) into the country by all DA Veterinary Quarantine Officers/Inspectors at all major ports of entry.
4. Frozen poultry meat with slaughter/process date of 21 days prior to the HPAI outbreaks are allowed to enter the country subject to veterinary quarantine rules and regulations.
5. Importation of meat products of poultry is subject to the conditions provided in Article 10.4.19, 10.4.20 and 10.4.26 of OIE Terrestrial Animal Health Code (2019).

This ORDER shall take effect immediately and shall remain enforced unless revoked in writing. All orders inconsistent herewith are deemed revoked.

² Heat treated products are acceptable following Chapter 10.4 of the OIE Terrestrial Animal Health Code (2016) provided that in addition to the Veterinary Health Certificate, the Competent Authority will include in the certification the following:

- Temperature and duration of heating or pasteurization of products; and
- There is no co-mingling of raw materials with any other materials of animal origin
