SUBJECT : COMPOSITION OF THE COMPLIANCE AND REGULATORY ENFORCEMENT FOR SECURITY AND TRADE OFFICE (CREST-O) AND THE TWO GROUPS UNDER CREST-O

Pursuant to Department Order No. ~~10~~, Series of 2019, "*Establishing the Compliance and Regulatory Enforcement for Security and Trade Office (CREST-O) in the Office of the Secretary, Department of Agriculture, Defining Its Powers and Functions, Providing Funds, Supplies, and Other Logistical Provisions Therefor, and for Other Purposes*", the following shall compose the CREST-O, Port-Based Anti-Smuggling Support Group (PBASSG) and Internal Security Group (ISG):

A. Compliance and Regulatory Enforcement for Security and Trade Office (CREST-O)

Responsible for the coordination, consolidation, harmonization of different regulatory functions to combat smuggling of agriculture/fisheries products; ensure compliance to monitoring and audit of the Department; and, ensure departmental and national security.
