**SUBJECT : CREATION OF LIVESTOCK PROGRAM EXECUTIVE COMMITTEE**

To fast track the institutionalization of the “New Thinking of the Philippine Agriculture” and attaining the vision of a Food Secure Philippines and Prosperous Farmers and Fisherfolk and to strengthen inter-agency collaboration, coordination, monitoring and evaluation of the National Livestock Program, the Livestock Program Executive Committee is hereby created, as follows:

Chairperson : Assistant Secretary for Livestock

Members : Director, Bureau of Animal Industry  
Executive Director, National Meat Inspection Service  
Executive Director, Philippine Carabao Center  
Administrator, National Dairy Authority  
Center Director, Agricultural Training Institute-International  
Training Center on Pig Husbandry  
Planning and Budget Officers of each Livestock Agencies

Secretariat : National Livestock Program Officers and Staff

The committee shall perform the following duties and responsibilities:

1. Manage the execution and monitoring of the directives by the Secretary especially in case of emergencies and all other issuances, policies and programs;
2. Harmonize livestock agencies plans and programs as well as put in place administrative arrangements to create convergence for greater performance outputs;
3. Oversee the formulation of the roadmaps of the various livestock and poultry commodities;
4. Formulate a new master/strategic plan for the National Livestock Program in line with the New Thinking of Philippine Agriculture;
5. Formulate resource allocation scheme that will determine the prioritization of the various programs/ projects/ activities;
6. Recommend changes/improvements for the performance indicators and or Program/Projects/Activities if deemed necessary.


7. Conduct Meetings/Workshops as may be deemed necessary for the effective and efficient performance of these assigned duties and responsibilities

Expenses that may be incurred in the performance of their duties and responsibilities such as traveling, per diems, logistic support and other incidental expenses shall be charged against the funds of the National Livestock Program, and other available funds subject to existing government accounting and auditing rules and regulations.

All officials and employees of the Department, including its Bureaus, attached Agencies and Corporations, DA Service Units, and Regional Field Offices are hereby directed to give their full support and cooperation in the performance of the committee's duties and responsibilities.
