**SUBJECT : SUGGESTED RETAIL PRICE OF BASIC AND PRIME
AGRICULTURAL AND FISHERY NECESSITIES AND
COMMODITIES IN METRO MANILA WET MARKETS**

WHEREAS, Section 9, Article XVI of the 1987 Constitution mandates that the State shall protect consumers from trade malpractices and from substandard and hazardous products;

WHEREAS, Republic Act (RA) No. 7581, otherwise known as the Price Act, declared that the State shall ensure the availability of basic necessities and prime commodities at reasonable prices at all times, without denying legitimate businesses a fair return on investment;

WHEREAS, the Price Act and its implementing rules and regulations (IRR) provides that the head of the implementing agency, such as the Department of Agriculture, thereof from time to time may issue suggested reasonable retail prices (SRPs) for any or all basic necessities and prime commodities under its jurisdiction for the information and guidance of producers, manufacturers, traders, dealers, sellers, retailers, and consumers;

WHEREAS, the Rule IV of the IRR provides that each implementing agency shall conduct regular monitoring of basic necessity and/or prime commodity in order to, among others, provide basis for establishing suggested retail prices;


WHEREAS, the Department of Agriculture, through the Office of the Undersecretary for Consumer Affairs and other attached agencies and entities mandated to monitor and/or institute regulatory measures for the basic agricultural and fishery commodities, conducted surveys, monitoring activities, and consultation meetings, as mandated and pursuant to the above;

NOW, THEREFORE, considering the powers and responsibilities vested upon the Department of Agriculture, it shall issue the SRP for the select agriculture commodities, applicable within Metro Manila, to inform the concerned sectors, as follows:
