SUBJECT : IMPLEMENTATION OF THE FARMERS AND FISHERFOLK ENTERPRISE DEVELOPMENT INFORMATION SYSTEM (FFEDIS) REGISTRATION AND DESIGNATION OF FFEDIS ENCODERS, VERIFIERS AND APPROVERS

In the interest of service and as mandated under Section 10 of the Republic Act 11321 also known as the Sagip Saka Act, the Agribusiness and Marketing Assistance Service (AMAS) and the DA Information and Communications Technology Service (DA-ICTS), will be implementing the Farmers and Fisherfolk Enterprises Development Information System (FFEDIS). The FFEDIS Registry System is a database of registered farmers and fisherfolk enterprises and other agri-fishery MSMEs. Included also in the system is the process of registration.

As such, they are authorized to claim/reimburse transportation expenses, toll fees, parking fees, food, communication allowance and other incidental expenses relative to the performance of their duties.


All expenses to be incurred by AMAS and ICTS personnel in the conduct of these activities shall be chargeable against AMAS fund while the expenses to be incurred by the regions shall be chargeable to their respective offices subject to the usual accounting and auditing rules and regulations.

All officials and employees of the Department, including its Bureaus, Attached Agencies and Corporations, DA-Service Units, and Regional Field Offices are advised of this assignments and directed to give their full support and cooperation.

This Order shall take effect immediately and remain in force until revoked.
