SUBJECT: DESIGNATION OF ASSISTANT DIRECTOR ROSANA P. MULA, Ph.D. AS PROGRAM DIRECTOR OF THE KABATAAN SA PAGPAPAUNLAD NG AGRIKULTURA AT PANGINGISDA PROGRAM (K-PAP)

In the exigency of service, **ASSISTANT DIRECTOR ROSANA P. MULA, Ph.D.** of Agricultural Training Institute (ATI) is hereby designated as **PROGRAM DIRECTOR OF THE KABATAAN SA PAGPAPAUNLAD NG AGRIKULTURA AT PANGINGISDA PROGRAM (K-PAP)** in concurrent capacity with her other designations.

As such, she shall perform the functions, duties and responsibilities inherent to the designation and such others as directed by the Secretary. The following are her specific tasks:

1. Oversees the timely and effective implementation of the Program's projects and activities within the DA and with partners;
2. Leads in expanding/maintaining a network to create and sustain opportunities for the youth at local and international level by establishing linkages and partnerships among key players and stakeholders;
3. Conducts regular consultations and coordination with youth sector organizations and the National Youth Commission;
4. Spearheads the preparation of the Program's Annual Work and Financial Plans for inclusion in the DA budget;
5. Conducts regular and periodic monitoring, evaluation, and reporting of the youth program's projects and activities, especially outcome and impact;
6. Provides regular reports, updates, and feedback to the Office of the Undersecretary for Policy and Planning;
7. Works with the Undersecretary for Policy and Planning in recommending policy improvements or program adjustments to ensure effective and efficient program projects and activities;
8. Performs other functions as may be assigned by the Undersecretary for Policy and Planning and/or the Secretary.

She is entitled to travelling allowance, per diems and incidental expenses that may be incurred in the performance of her duties and responsibilities as designated, chargeable against ATI funds and other available funds, subject to existing government accounting and auditing rules and procedures.
