

Memorandum Order No. <u>79</u> Series of 2020

Subject

Amendment to the Memorandum Order No. 52 Series of 2020 or the Implementing Guidelines for Rice Resiliency Project II

In order for the smoother and more efficient implementation of the Rice Resiliency Project II (RRP II), the following items are hereby amended:

II. Targets

Attached is the disaggregated targets by region for RRP II (Annex C)

IV. Project Scope

The project will be implemented in the 2020-2021 dry season cropping in 15 regions and the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) with rice-producing provinces/muinicipalities. Covered rice areas are the irrigated and rainfed lowland in RCEF and non-RCEF areas.

V. Project Implementation

Accredited partner dealers, distributors and FCAs may be collectively termed as "merchant/s" during the implementation of the RRP II.

C. Fertilizer Component

Fertilizer Distribution Modalities. The different fund sources that would be utilized for the implementation of RRP II fertilizer support requires to have multiple distribution modalities. For funds which allowed fertilizer procurement prior to the onset of the Dry Season crop, (e.g. NRP regular funds and a portion of the RRP I unutilized allotment) fertilizers would be distributed in kind following the scheme of 2 bags/ha for inbred and 3 bags/ha for hybrid.

Partner Dealer/Distributor/FCA Accreditation

Item No. 3. Has a capacity to provide for the equipment such as phones/tablets operating on android system version 6 and above, internet connectivity and manpower for facilitating online transactions.

Item No. 5. For merchants with multiple branches, all of the branches shall be required to attend training on voucher management platform conducted by ICTS and be subjected to regional accreditation. The accreditation certificate issued to the branches, however, would have a different numbering system.



D. Voucher Process

In lieu of the official receipts, a sales invoice may be issued and submitted by the accredited dealers, distributors and FCAs. For those who used a charge invoice as proof of transaction, sales invoice, collection receipt or other proof of settlement shall be issued once payment was made. Both charge invoice and the corresponding sales invoice, collection receipt or proof of settlement shall be collected and provided to LGUs.

Item No. 2. DA-RFO will encode the masterlist obtained from LGU (MA/CA), excluding those who already have received fertilizer in kind. The following rules will be implemented:

- a. For RFOs that can provide middle names, they may encode the full middle name, otherwise middle initials will suffice.
- For farmer-beneficiaries with no registered middle name in their birth certificate, the term "NMN" will be used and indicated in the masterlist.
- c. Shortened names such as Sto. For Santo, Sta. for Santa, Ma. for Maria and others will be accepted provided that the same is indicated in their birth certificate and identification card.
- d. For names of beneficiaries containing special characters aside from dash (-), the merchant shall consider the following character replacement:

e. For encoding addresses, the Philippine Standard Geographic Code (PSGC) shall be followed. For details, access the data thru the Philippine Statistics Authority (PSA) website: https://psa.gov.ph/classification/psgc/.

This digital version of the masterlist, to include the amount that the farmer is entitled to claim (based on his/her production area), shall be used as a transaction file. To facilitate fast accomplishment of this task, DA-RFOs are authorized to hire encoders for this purpose.



Item No. 3. DA-RFOs shall submit the transmit transaction files in CSV format to DA-Information and Communications Technology Service (ICTS) by batch. Each batch shall be on a per province basis. DA-ICTS shall conduct review, data cleaning and crossmatching of the submitted transaction files. Problems encountered in data shall be returned by ICTS to the concerned DA-RFO for correction also by batch.

Item No. 6. Farmer-beneficiaries shall personally bring the printed voucher, the reference code, the QR code, or RSBSA number together with proof of identification to accredited partner fertilizer dealers, distributors or FCAs, in purchasing fertilizer. In cases when a farmer-beneficiary could not personally appear and utilize the voucher due to health reasons and other special cases like quarantine restrictions, representatives shall be allowed to use the voucher, provided that: (i) said request shall be duly approved and with the conformity of an authorized DA-RFO official; and (ii) with the submission of the supporting documents by the designated authorized representative/s such as authorization letter and photocopy of the farmer-beneficiary and representative's ID.

Item No. 7. Offline transactions for RRP II will be excluded in the modalities in using vouchers for the claiming of fertilizers.

Item No. 8 For capturing proof of transaction, the first photo must show a picture of the farmer with the purchased fertilizer, while the second photo must include (1) farmer-beneficiary's signature, (2) his/her ID and (3) official receipt/sales invoice/charge invoice.

For cases where representatives are sent to utilize the voucher, the 2nd photo must also include the (4) authorization letter and (5) ID of the said representative.

Item No. 11. Accounts for reported deceased beneficiaries shall be cancelled and replaced by the eligible and registered beneficiary to be requested by the RFOs to DA FOS. Approved request shall be forwarded by DA FOS to DA-ICTS for issuance of new voucher for the replacement.

Accounts for a beneficiary whose data entries in the system show discrepancy, merchant shall release the assistance only upon presentation of certification of one-and-the-same identity of the beneficiary to be issued by the DA RFO, and immediately report to DA FOS and DA ICTS of the data discrepancy which shall be corrected as soon as the correct details of the beneficiary are provided. Template of the certificate is provided in Annex D.



This Order shall take effect immediately and shall remain in force until revoked in writing. All other Orders inconsistent herewith are deemed revoked.
