"ONE NATION STRATEGY" IN ENSURING FOOD SECURITY IN 2021

In the 50th Cabinet meeting on January 11, 2021, the President approved our joint action with other Departments and Offices. These are listed below and in the attached Cabinet decision. Related to this, the Task Group on Food Security also adopted the joint actions in its meeting on January 14, 2021. and The Task Group also recognized that the joint works last year enabled us to cope with the challenges of the pandemic and natural disasters in 2020. The Cabinet and the Task Group recognized the importance of the government and private sector working as one to address national food security.

In this regard, I'm assigning the following Undersecretaries and Assistant Secretary as DA focal persons for each action point to team-up with and mobilize the Departments and Offices that have indicated their willingness to work with us,.
