

Functions:

6. Submit a consolidated accomplishment report for Republic Act (RA) No. 11494 to the Office of the Secretary;
7. Coordinate with implementers of programs/projects funded under RA No. 11494;
8. Perform other functions as may be directed by the Secretary to ensure the smooth and efficient implementation of programs/projects under the *Bayanihan To Recover As One Act*.

All offices, bureaus and/or units implementing programs/projects funded under the *Bayanihan To Recover As One Act* are further instructed to assign report officers to assist the DA- Bayanihan PMO in the performance of its functions.
