Subject : Amendment to the Memorandum Order Nos. 52 and 79 Series of 2020 or the Implementing Guidelines for Rice Resiliency Project II

In order for the smoother and more efficient implementation of the Rice Resiliency Project II (RRP II), the following items are hereby amended:

THE PROJECT

The implementation of the Rice Resiliency Project II shall now cover the cropping seasons of 2021.

A. Objectives

Project is expected to contribute to the increase in production by 5% for cropping seasons of 2021.

B. Project Scope

The project will be implemented in 15 regions and in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) with rice-producing provinces/municipalities. Covered rice areas are the irrigated and rainfed lowland in RCEF and non-RCEF areas.

Start Date: Sept. 16, 2020

Ending Date: June 30, 2021

The following timelines will also be followed in relation to the end of the Project:

1. Claiming of vouchers

Farmer-beneficiaries can claim vouchers until June 15, 2021.

2. Payment of Merchants

Processing of payment for merchants is only until June 30, 2021.

3. Liquidation Period

DBP shall process and submit liquidation documents to DA Central Office and DA-RFOs until July 15, 2021.

This Order shall take effect immediately and shall remain in force until revoked in writing. All other Orders inconsistent herewith are deemed revoked.
