5. Conduct meetings as the need arises.


The PCC may invite representatives from the FAO – UN, the MAFAR – BARMM, the Municipality of Upi, the Municipality of Kauswagan, to be members and participate in the PCC. The FAO – UN Halal Project Consultants are also invited to participate and be part of the PCC. The Halal Program Management Office is hereby further instructed to coordinate and request the names of the representatives coming from the FAO, the MAFAR – BARMM, the Municipality of Kauswagan, and the Municipality of Upi, as approved by their respective organizations.

Expenses to be incurred for the activities related to the performance of the functions and assigned tasks shall be charged against the project funds, and other available funds subject to the usual accounting and auditing rules and regulations.

All officials and employees of the Department, including its Bureaus, Attached Agencies and Corporations, and Regional Field Offices are hereby advised to give full support and cooperation to the above in the performance of their duties and responsibilities.

This Order shall take effect immediately. All orders inconsistent herewith are deemed revoked.
