SUBJECT : CREATION OF A TECHNICAL WORKING GROUP (TWG) FOR THE PROCUREMENT AND CONSTRUCTION OF FIRST BORDER INSPECTION FACILITY

In the exigency of public service and in order to expedite the establishment of the Cold Examination Facility in Agriculture (CEFA) as *Facilities for First Border Inspection in major international ports*, the Department hereby creates a Technical Working Group (TWG) that will be responsible for the following functions:
