SUBJECT: DESIGNATION OF DEPUTY EXECUTIVE DIRECTOR ERIC C. DIVINAGRACIA AS OFFICER-IN-CHARGE, DEPUTY EXECUTIVE DIRECTOR FOR PESTICIDE, FERTILIZER AND PESTICIDE AUTHORITY (OIC-DED FOR PESTICIDE, FPA)

In the exigency of service and in view of the issuance of new appointment to Dir. Romirose B. Padin, **DEPUTY EXECUTIVE DIRECTOR ERIC C. DIVINAGRACIA** of Philippine Council for Agriculture and Fisheries (PCAF) is hereby designated as **OFFICER-IN-CHARGE, DEPUTY EXECUTIVE DIRECTOR FOR PESTICIDE, FERTILIZER AND PESTICIDE AUTHORITY (OIC-DED FOR PESTICIDE, FPA)**

As such, he shall perform the following functions, duties and responsibilities:


1. Supervise the Pesticide Division in its day to day functions:
 - Monitoring of supply and demand
 - Processing of import application
 - Licensing and registration
 - Rationalization of production facilities
 - Information and dissemination program
2. Attend conferences, seminars, meetings, etc. related to pesticide, including international representation;
3. Assist the Executive Director in promulgating and implementing policies affecting pesticide marketing, distribution, pricing, etc.
4. Perform other tasks as needed.

He is entitled to RATA, traveling allowance, per diems, and other incidental expenses that may be incurred in the performance of his functions, duties and responsibilities, chargeable against FPA funds, subject to existing government accounting and auditing rules and procedures.

All officials and employees of the Department, including its Bureaus, Attached Agencies and Corporations, and Regional Field Offices are hereby advised to give their full support and cooperation to OIC-Dep. Exec. Dir. E. Divinagracia in the performance of his duties and responsibilities.

This Order shall take effect immediately and shall remain in force unless revoked in writing. Special Order (SO) No. 722, Series of 2021 and all orders, memoranda, and issuances inconsistent herewith are deemed revoked.
