The abovementioned personnel shall implement and facilitate the FFEDIS registration of the farmers and fisherfolk enterprises and other agri-fishery related MSMEs in their respective regions. As such, they are authorized to claim/reimburse travelling expenses, toll fees, parking fees, food, communication allowance, and other incidental expenses relative to the performance of their duties.

All expenses to be incurred by AMAS and ICTS personnel in the conduct of these activities shall be chargeable against AMAS funds while the expenses to be incurred by the regions shall be chargeable to their respective offices subject to the usual accounting and auditing rules and regulations.

All officials and employees of the Department, including its Bureaus, Attached Agencies and Corporations, DA-Service Units, and Regional Field Offices are advised of these assignments and directed to give their full support and cooperation.

This Order shall take effect immediately and shall remain in force until revoked. All other Orders and issuances inconsistent herewith are deemed revoked.
