As members of the BSWM BAC TWG, the designated DA Personnel shall perform the following duties and responsibilities provided under Section 12.1 of the 2016 Revised IRR of RA 9184:

Assist the BSWM BAC in the:

1. Review of the Technical Specifications, Scope of Work, and Terms of Reference;
2. Review of Bidding Documents;
3. Shortlisting of Consultants;

4. Eligibility Screening;
5. Evaluation of Bids;
6. Post-Qualification; and
7. Resolution of Request for Reconsideration.

On the hand, as members of the BSWM BAC Secretariat, they shall provide guidance on the compliance with procurement process per government procurement laws.

The BAC TWG and Secretariat shall be entitled to traveling expenses and honoraria chargeable against BSWM funds, subject to availability of funds and existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
