SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE PREPARATION OF THE FY 2023 BUDGET EXECUTION DOCUMENTS (BEDS) OF THE HIGH VALUE CROPS DEVELOPMENT PROGRAM (HVCDP) IN THE NATIONAL CAPITAL REGION ON OCTOBER 10-14, 2022
