SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE DEPARTMENT OF AGRICULTURE REGISTRY SYSTEM FOR BASIC SECTORS IN AGRICULTURE (DA RSBSA) DATA PRIVACY TRAINING - WORKSHOP

The DA Registry System for Basic Sectors in Agriculture–National Program Management Office (RSBSA–NPMO) shall conduct the DA RSBSA Data Privacy Training-Workshop from October 24-28, 2022 in Region VII (Central Visayas).

The following are the objectives of the said activity:

- Brief the assigned Compliance Officers for Privacy, Regional Personal Information Controllers, and Regional Personal Information Processors of the Regional RSBSA offices on the general provision of the Data Privacy Act of 2012 and its Implementing Rules and Regulations;
- Discuss protocols captured in the Data Privacy Manual for the execution of data sharing and protection matters in the RSBSA program; and
- Conduct a rapid Privacy Impact Assessment to review the possible risks in the current data collection process; propose for improvement from the current setting, and assess gaps and factors to be considered to implement the proposal.
