SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE NATIONWIDE IMPACT ASSESSMENT AND EVALUATION OF AGRICULTURAL COMPETITIVENESS ENHANCEMENT FUND (ACEF) PROGRAM IMPLEMENTATION

The Agricultural Competitiveness Enhancement Fund (ACEF) Program Management Office and the Office of the Undersecretary Agri - Industrialization will conduct the nationwide impact assessment and evaluation of ACEF Program Implementation under Republic Act (RA) No. 10848 to be held on December 12-16, 2022 at Region VI, which aims, to:
