SUBJECT: AMENDMENT TO SPECIAL ORDER NO. 742, SERIES OF 2022 RE: AUTHORITY TO CONDUCT AND ATTEND THE DEPARTMENT OF AGRICULTURE REGISTRY SYSTEM FOR BASIC SECTORS IN AGRICULTURE (DA RSBSA) DATA PRIVACY TRAINING - WORKSHOP
