

A minimum of thirty (30) and maximum of forty (40) physical participants, subject to the existing minimum health protocols of the Inter-Agency Task Force, shall be allowed to attend the activity physically. The rest of the participants shall attend using virtual platforms.

Expenses incurred in the conduct of the activity, such as food, accommodation, venue, and activity materials, shall be charged against the DA OSEC Funds earmarked for NCI-SRD, subject to existing government auditing and accounting regulations. In addition, traveling expenses and per diem of the participants shall be chargeable against the funds of the respective agencies concerned.

This Order shall take effect immediately and be considered revoked upon completion of the activity. All orders, memoranda and issuances inconsistent herewith are deemed revoked.
