SUBJECT: CREATION OF COMMITTEE ON REVISION OF DA ADMINISTRATIVE ORDER NO. 07, OR THE RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT NO. 7581 IN RELATION TO AGRICULTURAL COMMODITIES

The Committee shall have the following functions:

1. Lead in drafting the revision of the Rules and Regulations Implementing R.A. 7581 in relation to Agricultural Commodities
2. Spearhead the conduct of consultative meetings with stakeholders on the revision of the Rules and Implementing R.A. 7581.
3. Perform any other functions or activities as may be needed or as designated by the Secretary

The Secretariat shall have the following functions:

1. Provide technical and administrative support for the Committee;
2. In-charge of scheduling of meetings and preparing, circulating, keeping the formal records such as the Official Minutes of the Meetings, and other documents;
3. In-charge of submission of reports to the Committee and Office of the Secretary.

Within **five (5) days** from the approval of this Order, the Committee Members, particularly the attached agencies, and the Secretariat **shall** designate a specific person to be an alternate member.

All expenses that may be incurred in the performance of their duties and responsibilities shall be chargeable against their respective office's funds and other available funds, subject to existing government accounting and auditing rules and regulations procedures.

This Order shall take effect immediately and shall remain in force unless revoked through writing. All Orders or parts thereof inconsistent herewith are deemed revoked.
