SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE DEPARTMENT OF AGRICULTURE REGISTRY SYSTEM FOR BASIC SECTORS IN AGRICULTURE (DA-RSBSA) CONSULTATION AND WRITESHOP WITH THE PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES – OTHER PRIORITY PROGRAM COMMITTEE ON GENDER EQUALITY AND SOCIAL INCLUSION (PCAF OPPC-GESI)

The DA Registry System for Basic Sectors in Agriculture–National Program Management Office (RSBSA–NPMO) shall conduct the DA RSBSA Consultation and Writeshop with PCAF Other Priority Program Committee on Gender Equality and Social Inclusion (OPPC-GESI) on December 20-21, 2022 at the Department of Agriculture – Office of the Secretary (OSEC).

This consultation and writeshop is in relation to the issuance of the PCAF Resolution No. 5, Series of 2022, dated 22 July 2022, that recommends the DA RSBSA–NPMO to immediately conduct workshop and consultation for the assessment and possible revision of the RSBSA Guidelines and Tools to ensure an inclusive and gender-responsive registration process.

The objectives of the activity are as follows:

- a. Brief the participants on the salient provisions of the Magna Carta of Women (RA 9710), Magna Carta of Disabled Persons (RA 7277), and the Indigenous Peoples' Rights Act of 1997 as discussed by the invited resource speakers from the respective sectors;
- b. Revisit the definition of terms and registration process in the RSBSA Guidelines in consultation with the invited representatives of sectors for Gender Equality and Social Inclusion; and
- c. Discuss and draft recommended revisions of the RSBSA Guidelines and Tools in pursuance to the provisions of Magna Carta of Women (RA 9710), Magna Carta of Disabled Persons (RA 7277), and the Indigenous Peoples' Rights Act of 1997.
