SUBJECT: AUTHORITY TO CONDUCT THE YEAR-END ASSESSMENT AND PLANNING WORKSHOP FOR FY 2023 OF THE OFFICE OF THE UNDERSECRETARY FOR SPECIAL CONCERNS AND FOR BARMM ON DECEMBER 13-16, 2022 IN CORDILLERA ADMINISTRATIVE REGION (CAR)
