SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE SECOND PHASE OF THE UPDATING OF THE FISHERIES NATIONAL ADMINISTRATIVE REGISTER (FNAR) ON NOVEMBER 21-25, 2022, TO BE HELD IN A NON-GOVERNMENT FACILITY WITHIN METRO MANILA

In the exigency of service and to ensure effective implementation of the mandates of the Adjudication Committee pursuant to Section 130 of the Implementing Rules and Regulations of the Amended Fisheries Code, the BFAR-Adjudication Committee Secretariat is hereby authorized to conduct the Second Phase of the Updating of the Fisheries National Administrative Register (FNAR) which will be held on November 21-25, 2022, in a non-government facility within Metro Manila.

This activity aims to upgrade the features and functionality of the FNAR to provide a more efficient way of handling administrative cases decided/ disposed by the Adjudication Committee. This system shall ensure that transactions and communications of both national and regional offices be properly consolidated and secured in a centralized database for traceability of records, efficiency and effectiveness, established quality management systems, strengthened workforce capacity, enhanced organizational governance, and ensured transparency and accountability.
