SUBJECT: AUTHORITY TO DESIGNATE NATIONAL FOCAL AND ALTERNATE FOCAL POINTS FOR THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS (ASEAN) BODIES OR GROUPS FOR VETERINARY MEDICINE, ANIMAL HEALTH AND THE ANIMAL INDUSTRY

In the exigency of the service and to ensure the continuity of the representation of the Philippines to the Association of Southeast Asian Nations (ASEAN) bodies or groups related to Veterinary Medicine, Animal Health and the Animal Industry, the Bureau of Animal Industry Director is hereby authorized to appoint the National Focal and Alternate Focal Points for the following ASEAN bodies or groups:

1. ASEAN Sectoral Working Group on Livestock;
2. ASEAN National Focal Points on Veterinary Products;
3. ASEAN Coordinating Centre for Animal Health and Zoonoses Preparatory Committee;
4. ASEAN Laboratory Directors Forum (ALDF);
5. ASEAN Veterinary Epidemiology Group (AVEG);
6. ASEAN Communication Group for Livestock (ACGL);
7. Avian Influenza Group for ASEAN (AIGA);
8. Expert Working Group on Good Animal Husbandry Practices (EWG-GAHP);
9. ASEAN Animal Identification and Traceability Systems (AAITS);
10. ASEAN Regional Animal Health Information System (ARAHIS);
11. Classical Swine Fever (CSF) and Other Swine Diseases; and
12. Other ASEAN bodies, groups, programs and projects as related to Veterinary Medicine, Animal Health and the Animal Industry

Traveling expenses of the Focal and Alternate Focal Points to attend and participate in the meetings of the above ASEAN bodies/groups shall be charged to the available funds of the Department of Agriculture, Bureau of Animal Industry or the Focal and Alternate Focals' respective Bureaus subject to the usual accounting and auditing rules and regulations.

All officials and employees of the Department including its Bureaus, Attached Agencies and Corporations, and Regional Field Offices are hereby advised to give their full support

and cooperation to the Bureau of Animal Industry Director in the performance of the abovementioned duties and responsibilities.

This Order shall take effect immediately and shall revoke all other Orders/Memoranda inconsistent herewith.
