SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE FY 2022 YEAR-END ASSESSMENT AND FY 2024 PLANNING WORKSHOP OF THE HIGH-VALUE CROPS DEVELOPMENT PROGRAM (HVCDP) AND THE NATIONAL URBAN AND PERI-URBAN AGRICULTURE PROGRAM (NUPAP) IN CALABARZON ON FEBRUARY 6-10, 2023
