SUBJECT : AUTHORITY TO CONDUCT THE WORKSHOP ON THE PERFORMANCE REVIEW AND ASSESSMENT OF THE AGRIBUSINESS AND MARKETING ASSISTANCE SERVICE (AMAS) PROGRAMS, ACTIVITIES AND PROJECTS
