SUBJECT: AUTHORITY TO ATTEND THE MANAGEMENT COMMITTEE (MANCOM) MEETING ON FEBRUARY 1-3, 2023 IN REGION IV A

In the exigency of service, the following DA Officials and Heads of Agencies (see attached list) are hereby authorized to participate/attend the **MANCOM Meeting in Region IV A (venue to be confirmed) on February 1-3, 2023** (exclusive of travel time).
