AUTHORITY TO CONDUCT THE 17TH NATIONAL ORGANIC AGRICULTURE CONGRESS (NOAC) ON 21-24 MARCH 2023 AT UNIVERSITY OF **SOUTHERN MINDANAO**

In the exigency of service, the National Organic Agriculture Program and the Department of Agriculture Regional Field Office XII are hereby authorized to spearhead the conduct of the 17th National Organic Congress on 21-24 March 2023 through the University of Southern Mindanao as an event co-organizer and host.
