## SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE PHILIPPINES (PH) EUROPEAN UNION (EU) DIALOGUE ON ILLEGAL, UNREPORTED, AND UNREGULATED (IUU) FISHING ON 30 JANUARY-03 FEBRUARY 2023, TO BE HELD IN A NON-GOVERNMENT FACILITY WITHIN METRO MANILA AND GENERAL SANTOS CITY

In the exigency of service, and in order to ensure effective implementation of the mandates of the Philippines on the traceability of all seafood products exported to the EU member countries and the country's compliance with its commitments in addressing Illegal, Unreported, and Unregulated (IUU) Fishing, the Office of the Assistant Director for Technical Services is hereby authorized to conduct the Philippines-European Union (EU) Dialogue on IUU Fishing on 30 January-03 February 2023 within Metro Manila and General Santos City.

The activity aims to revise the progress in the action plans and discuss the existing established control measures in terms of transshipments and landings, raw material importation, traceability along the supply chain, and implementation of the port state measures.
