SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE FIELD DATA GATHERING ACTIVITIES OF THE BUREAU OF AGRICULTURE AND FISHERIES STANDARDS (BAFS) – STANDARDS RESEARCH DIVISION (SRD) RELEVANT TO THE DEVELOPMENT AND AMENDMENT OF THE PHILIPPINE NATIONAL STANDARD FROM MARCH TO AUGUST 2023
