SUBJECT: DESIGNATION OF MR. ANGELO S. BUGARIN, CHEMIST IV AS OFFICER-IN-CHARGE OF PESTICIDE REGULATIONS DIVISION (PRD) OF THE FERTILIZER AND PESTICIDE AUTHORITY (FPA)

In the exigency of service, **MR. ANGELO S. BUGARIN**, is hereby designated as **OFFICER-IN-CHARGE** for **PESTICIDE REGULATIONS DIVISION (PRD)** of the FPA in concurrent capacity as **CHEMIST IV**.

As such, he shall perform the following functions, duties and responsibilities inherent to the designation and such others as may be directed by the Deputy Executive Director for Pesticide including but not limited to the following functions:

1. Oversee the overall operations of PRD and ensures that the functions of PRD and the following regulatory services are well carried out within prescribed timeframe.
 - a. Product registration of pesticides, PIP, and other agricultural chemicals
 - b. Issuance of Experimental Use Permit
 - c. Issuance of licenses to pesticide handlers & dealers
 - d. Issuance of CAIP & export permits
2. Facilitate the formulation and updating of policies and guidelines related to pesticide regulations
3. Coordinate the regular operations of the Pesticide Policy and Technical Advisory Committee (PPTAC)
4. Make recommendations for FPA's compliance with its national and international membership commitments, such as Stockholm Treaty, Rotterdam Treaty, Montreal Protocol, ASEAN Expert Working Group for MRL Harmonization, and many more.
5. Conduct industry meetings/dialogues to discuss issues related to pesticides and other agricultural chemicals.
6. Perform various administrative functions of PRD, such as preparation of annual workplan, budget, DPCR, IPCR, etc.
7. Perform other functions as may be assigned from time to time

He is entitled to RATA and travelling expense, per diems and incidental expenses that may be incurred in the performance of his duties and responsibilities as designated, chargeable against the FPA funds, subject to the existing government accounting and auditing rules and procedures.

All officials and employees of FPA are hereby advised of this designation and directed to give their full support and cooperation to Mr. Bugarin in the performance of his duties and responsibilities.

This Order shall take effect immediately and shall remain in force until revoked in writing or Chief Agriculturist for PRD has been appointed. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
