**SUBJECT : AUTHORITY TO CONDUCT TRAINING ON INTEGRATED ENVIRONMENTAL AND SOCIAL SAFEGUARDS MAINSTREAMING: ENVIRONMENTAL AND SOCIAL ASSESSMENT AND RIGHT-OF-WAY AND SITE ACQUISITION FOR IMPLEMENTATION OF ENTERPRISE PROJECTS IN NATIONAL CAPITAL REGION, OUTSIDE GOVERNMENT FACILITIES**

In the exigency of service, the Philippine Rural Development Project (PRDP) is hereby authorized to conduct Training on Integrated Environmental and Social Safeguards Mainstreaming: Environmental and Social Assessment and Right-of-Way and Site Acquisition for Implementation of Enterprise Projects on February 27- March 3, 2023 in National Capital Region.

The training aims to gain knowledge on the PRDP Safeguards Framework, its basis, and key concepts; the importance of Social and Environmental Safeguards; and to apply the learnings in the preparation, evaluation, and implementation of agricultural infrastructure and enterprise subprojects through training. At the end of the activity, a post-activity report will be prepared to include an assessment of the topics discussed which will serve as a benchmark on the next series of training on mainstreaming.
