## SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE AGRIBUSINESS INVESTMENT EVALUATION AND DECISION TRAINING COURSE FOR VISAYAS AND MINDANAO CLUSTERS

In the interest of service, the Agribusiness and Marketing Assistance Service -Agribusiness Promotion Division (AMAS-APD) is hereby authorized to conduct the Agribusiness Investment Evaluation and Decision Training Course for **Visayas Cluster on May 8-10, 2023 in Region 7** and for **Mindanao Cluster on June 5-7, 2023 in Region 10**.

The training program will provide the target participants with the necessary knowledge to analyze potential agribusiness investments through financial parameters. Further, it will enhance the capability of the Regional Agribusiness and Marketing Assistance Divisions to assist the Farmers, Cooperatives and Associations in their area of responsibility.

Specifically, the training program aims to:

- 1. Discuss the financial management in agribusiness ventures.
- 2. Discuss the basic financial management models and capital budgeting techniques used in assessing the viability of an agribusiness venture.
- 3. Hands-on coaching on the preparation of cash flow projections and financial viability analysis.
- 4. Generate viable regional priority agribusiness opportunities.
- 5. Prepare an evaluation report of the selected business proposal.
