**SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE FY2024
PLANS AND BUDGET PREPARATION WORKSHOP OF THE
BUREAU OF FISHERIES AND AQUATIC RESOURCES**

In the interest of service, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct the FY 2024 Plans and Budget Preparation Workshop on February 28 – March 2, 2023 in Quezon City.

The said activity aims to:

- Identify the BFAR priority programs and projects for FY 2024;
- Discuss whether identified regional plans and budget are aligned with the national plans of the BFAR and the Department of Agriculture;
- Ensure that the identified regional plans and budget were coordinated with their respective Regional Development Council (RDC) and Civil Society Organizations (CSOs);
- Ensure readiness of project implementation, projects must be shovel-ready; and
- Ensure continued adoption of the following reforms:
 - Implementation of the Cash Budgeting System (CBS)
 - 2-Tier Budgeting Approach (2TBA)
 - Unified Account Code System (UACS)
 - Program Expenditure Classification (PrExC) format
 - Disaggregation of lump-sum amounts within the agency specific budget
