**SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE CONSULTATION AND WORKSHOP ON DATA GATHERING FOR THE PHILIPPINE ANIMAL INDUSTRY MANAGEMENT INFORMATION SYSTEM (Phil-AIMIS)**

The Phil-AIMIS is established to serve as central repository/data bank and knowledge portal for DA Livestock Agencies such as the Bureau of Animal Industry, National Meat Inspection Service, Philippine Carabao Center, National Dairy Authority and for the Livestock Industry. The System stores data necessary for evidence-based policy and plan formulation, trend analysis and probabilities, among others.

The National Livestock Program (NLP) in its implementation of various livestock development projects collects data and information valuable and helpful to Phil-AIMIS users. In view of this, the NLP is hereby authorized to conduct the **Consultation and Workshop on Data Gathering for the Phil-AIMIS on March 21-24, 2023 in Quezon City.**

This activity involves consultation and workshop among livestock agencies and NLP Focals from Regional Field Offices to determine the data/inputs information from the NLP to be inputted in the established databases or to be established under the Phil-AIMIS.
