## SUBJECT : AUTHORITY TO CONDUCT THE PRDP NPCO – PSOs FIRST QUARTER COORDINATION WORKSHOP

In the exigency of service, the Philippine Rural Development Project (PRDP) is hereby authorized to conduct the PRDP National Project Coordination Office – Project Support Offices (NPCO – PSOs) First Quarter Coordination Workshop on **March 20-24, 2023** in **Region 4A**.
