**SUBJECT : AUTHORITY TO CONDUCT TWO (2) SESSIONS OF TECHNICAL WRITESHOP ON FORMULATION AND DEVELOPMENT OF PROJECT CONCEPT NOTES (PCNs) ON PUBLIC-PRIVATE PARTNERSHIPS (PPPs) IN THE AGRI-FISHERIES SECTOR IN SUPPORT OF THE NATIONAL AGRICULTURE AND FISHERIES MODERNIZATION AND INDUSTRIALIZATION PLAN (NAFMIP) 2021-2030 ON MAY 8-12, 2023 AND MAY 29-JUNE 2, 2023**

In the interest of service, the DA-Project Development Service - Public-Private Partnership Unit (DA-PDS PPPU) is hereby authorized to conduct the **Technical Writeshop on Formulation and Development of Project Concept Notes (PCNs) on Public-Private Partnerships (PPPs) in the Agri-Fisheries Sector in support of the National Agriculture and Fisheries Modernization and Industrialization Plan (NAFMIP) 2021-2030** which will be physically held on May 8-12, 2023 at Region IV-A and May 29-June 2, 2023 at Region III.

The activity aims to: 1) generate and identify prospective projects in support of NAFMIP 2021-2030 that can be possibly funded through PPP and to be presented in the PPP Investment Forum 2023; 2) develop Project Concept Notes (PCNs) of the projects with potential PPP arrangement, and advise the appropriate modality by which the project would be best implemented; and 3) familiarize the regional field offices (RFOs), banner programs and PDS (as evaluators) on the concept of Public-Private Partnerships in the agriculture and fisheries sector and develop an in-depth understanding of the different PPP modalities.
