SUBJECT: AUTHORITY TO CONDUCT WORKSHOP FOR THE FINALIZATION OF THE DRAFTS OF THE NATIONAL ACTION PLANS FOR SOYBEAN AND SORGHUM

The National Corn Program (NCP) is hereby authorized to conduct a workshop for the finalization of the drafts of the National Action Plans for Soybean and Sorghum 2023-2030 (NAPSS 2023-2030) Workshop on 22-26 May 2023 in Region IV-A.

The activity aims to:

- Review and discuss the regional action plans proposed by the Regional Technical Working Groups (RTWGs);
- Address issues and concern relative to inputs, production, processing, machineries, research, policies and marketing of soybean and sorghum;
