SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE FIRST QUARTER ASSESSMENT OF PROGRAMS, PROJECTS AND ACTIVITIES FUNDED UNDER QUICK RESPONSE FUND (QRF) AND NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (NDRRMF)

In the exigency of service, the Department of Agriculture Disaster Risk Reduction and Management Service (DA DRRMS) is hereby authorized to conduct the First Quarter Assessment of Programs, Projects and Activities (PPAs) funded under the Quick Response Fund (QRF) and the National Disaster Risk Reduction and Management Fund (NDRRMF) on April 24-28, 2023 in Ilocos Region.

The activity aims to:

1. Assess the physical and financial accomplishments of various rehabilitation and recovery PPAs implemented in CY 2019-2022 and 1st quarter of 2023 under the QRF and NDRRMF;
2. Determine the problems encountered in the implementation of PPAs, recommend solutions and prepare action plan to achieve the targets;
3. Discuss the Guidelines on the Utilization of Quick Response Fund and the Guidelines on indemnification for Avian Influenza; and
4. Present the updates implemented in the Disaster Risk Reduction Management Information System (DRRMIS) as a result of the consultation with the target users.
