Subject: **CREATION OF A TECHNICAL WORKING GROUP FOR THE IDENTIFICATION OF INVESTMENT PROJECTS UNDER THE PUBLIC-PRIVATE PARTNERSHIP (PPP) SCHEME**

In the interest of service and to ensure a rich pipeline of investment and developmental projects under the Public-Private Partnership (PPP) Scheme, a Technical Working Group (TWG) is hereby created as follows:

Composition:

Program Director, High Value Commercial Crops Programs (HVCP)
Program Director, National Urban and Peri-Urban Agriculture Program (NUPAP)
Director, Bureau of Animal Industry (BAI)
Director, Bureau of Agriculture and Fisheries Engineering (BAFE)
Director, Bureau of Fisheries and Aquatic Resources (BFAR)
Director, Legal Service
Director, National Livestock Program (NLP)
Executive Director, National Meat Inspection Service (NMIS)
Executive Director, Philippine Council for Agriculture and Fisheries (PCAF)
Chief, Project Development Service-Project Identification and Evaluation Division (PDS- PIED)

Duties and responsibilities:

1. Coordinate with the Office of the Presidential Adviser on Investment and Economic Affairs regarding the formulation of projects under the PPP Scheme;
2. Identify and recommend, within duly crafted sectoral and commodity policies, programs, and plans, prospective and appropriate projects for implementation through PPPs;
3. Determine indicative PPP modalities that can be utilized for identified projects for implementation pursuant to relevant existing laws, rules, and regulations;
4. Carry out consultative meetings and coordinate with possible implementing agencies of identified projects for prospective implementation as solicited PPPs;

5. The TWG members shall serve as the focal person/s in their respective offices or agencies; and
6. Submit reports and recommendations to the Senior Undersecretary.

The members of the Secretariat will be technical support staff from the following:

1. PDS/PPP Unit
2. AMAS-AIPD

Duties and Responsibilities

1. Coordinate with officials/staff, offices, stakeholders, and consultants on the conduct of activities concerning the identification of PPPs.
2. Provide technical and administrative support to the TWG in the performance of their respective duties and responsibilities provided herein.
3. Perform other tasks as may be directed by the TWG.

In the absence of their respective Heads, an official representative/alternate with a rank of Division Chief or its equivalent should attend the meetings.

This Order shall take effect immediately and shall remain in full force until revoked in writing. All other orders, memoranda, and issuances inconsistent herewith are deemed revoked.
