The Technical Working Group shall be responsible for the following:

- 1. Revisit and review existing policies and issuances of the Department in relation to the transboundary movement of livestock;
- 2. Identify and map Local Government Units with livestock-centric industries;

3. Coordinate with the Department of the Interior and Local Government (DILG) and other relevant agencies in the review, crafting, and issuance of the revised/updated protocols on the prevention and control of emerging livestock diseases.

Expenses to be incurred in the conduct of the activities of the technical working group are chargeable against the respective bureau's or national banner program's fund subject to the availability of funds and the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
