**SUBJECT** 

AUTHORITY TO CONDUCT THE PHILIPPINE COMMITTEE SUMMIT AGAINST ILLEGAL. UNREPORTED AND

**UNREGULATED FISHING** 

In the interest of service, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct a Philippine Committee Summit against Illegal, Unreported and Unregulated Fishing to be held in Metro Manila on May 25,2023.

The Philippine Committee (PhilCom) against Illegal, Unreported and Unregulated Fishing is mandated to ensure the implementation of the NPOA-IUUF, to provide policy guidance and to develop capacity building programs. The Committee is also mandated to submit an annual report to the President on the implementation of the Executive Order and of the NPOA-IUUF. The PhilCom adopts and promulgates internal rules and procedures that will serve as guidelines in the internal organization and operations.
