SUBJECT: AUTHORITY TO CONDUCT THE INVESTMENT FORUM FOR

PUBLIC-PRIVATE PARTNERSHIPS IN THE AGRICULTURE AND

**FISHERIES SECTOR** 

In the interest of service, the Public-Private Partnership Unit of the DA-Project Development Service is hereby authorized to conduct the **Investment Forum for Public-Private Partnerships (PPPs) in the Agriculture and Fisheries Sector** to be held on **21 September 2023** in the **National Capital Region** (venue to be announced).

This investment forum aims to promote Public-Private Partnerships and forge partnerships/collaborations with private entities that can bankroll critical projects that will deliver much-needed services to farmers and fisherfolks and/or as technical partners in projects for the agriculture and fisheries sector. Furthermore, this forum is a venue to facilitate the exchange of ideas to determine possible and potential PPP projects, policy frameworks, and other interventions for PPPs.
