**SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE MIDYEAR ASSESSMENT ON THE IMPLEMENTATION OF SMALL-SCALE IRRIGATION PROJECTS (SSIP) UNDER DA BANNER PROGRAMS**
