The TWG shall be responsible for the following:

1. Prepare the feasibility study (FS) for the Juncao Demonstration Center in the Philippines project;
2. Gather relevant local and international data and information relative to the preparation of the FS;
3. Establish the market, technical, economic, financial, institutional, legal, social, environmental and risk analyses based on updated and actual gathered data.
4. Prepare a realistic implementation plan for the proposed project as well as come-up with recommendation/s on the best applicable technologies and appropriate alternatives for the project.
5. Identify and validate appropriate area/s for the project;
6. Engage and/or coordinate with other DA operating units (OUs), government agencies, local government units (LGUs), civil society organizations (CSOs) during the conduct of the FS that may be the sources of the necessary data and information;
7. Identify related projects or initiatives in the country, if any, for possible complementation and/or data source/s.
8. Submit progress report to the Project Preparation Team (PPT); and
9. Perform other tasks as assigned by the PPT.
